Did you know that WU offers the Direct to Bank (D2B) service for transactions sent to Colombia?

Help grow this corridor and business segment by reminding Agents that the service is available.

Offered by our Master Agent **Giros y Finanzas** for the WU brand in Colombia, the D2B to Colombia service is activated in more than 160 countries through retail and 37 countries through digital channels.

Key information:

- Maximum limit per transaction is US\$ 7,500.00 (for some Send Countries there are lower local limits that must be applied)
- Payout in local currency (COP)

Please keep in mind that receivers in Colombia who meet the following thresholds must enroll locally to receive a direct to bank transaction:

- Individual transaction above US\$ 125.00,
- Received more than 2 transactions during a 3-month period
- Received more than 4 transactions during a 6-month period
- Received more than 5 transactions during a 12-month period

When a Receiver is not yet enrolled, and meets one of the thresholds listed above, Giros y Finanzas representative will contact the Receiver **thru phone** to enroll. If the representative is unable to reach the Receiver, the transaction will be blocked for 10 days until the Receiver has successfully enrolled. if not, it will be automatic refund in the <u>day 11</u>.

- Bank name in Spanish (as list below), account number and type of account
- Receiver ID number*, Address, City, State, Mobile number with country and city code

*The ID number from the Receiver should be the same number provided when he or she opened the bank account. If this number is not correct, the bank will reject the transaction.

*D2B sender/receiver could be the same person.
